# **Volunteer update Tuesday 2nd June 2020**

# Volunteers returning to the Railway.

Plans are now being put in place to allow a limited number of volunteers to return to the Railway to undertake <u>essential outside maintenance</u> work. This is the first step in the reintroduction of volunteers back to the railway. Managers in Operations, P Way, S&T and Estate Station Managers will actively manage work to be done, ensuring volunteers - initially in groups of two - are properly briefed on the arrangements for safe working, the issue of any ppe required and the provision of gloves, sanitiser and access to hand washing facilities, before work starts. Volunteers will be required to maintain social distancing at all times.

A more detailed briefing note is being prepared and will be made available shortly.

Volunteers wishing to work in these areas should contact the relevant Manager to indicate their willingness to work, as that a pool of volunteers can be maintained. The relevant contact details are:-

## Fundraising.

We are making solid progress with our SOS appeal, nearing the half-way mark - £169,000 at the time of writing - towards our target of £360,000.

We are in the process of producing more fundraising videos, to re-energise the appeal. Some further excellent work done by volunteers Josh Voce and Kevin Babey in producing these, and other fundraising videos, is very welcome.

The new videos look at the wider role of the Swanage Railway in the Purbeck area and describe our efforts to manage the railway at present and to find a way through the impact of the crisis.
